Solano’s Local Artist & Growers

Come help the Solano County Fair showcase of Solano’s Local Artists & Growers. We have an area just for you and have designed it to be flexible to accommodate your very busy schedule.

Here is how it works:

- We provide a 10’x10’ canopied demonstration area for you to show how your product is produced.
- As part of your demonstration, you can sell your products without paying for a space or commission to the Fair.
- You only have to commit to as much time as your schedule will allows.
- This is a shared demonstration space, rotating among various local artists and growers, based on the time each of you are available (see scheduling sheet, pg.2.)
- Each two-hour time slot requires a 20 minute demonstration that is entertaining and informative.
- You can gain exposure and sales while fairgoers learn about our interesting Local Artists & Growers.
- And, once again, there is no fee for you to participate in this program. But, we do ask for a report of your sales and that you help promote your demonstration.

Complete and return this application with your product and demonstration information to the Solano County Fair at the above address by June 1, 2016. Applications submitted without product and demonstration information will not be considered.

Waiver: If you (or your group) is selected to participate at the Solano County Fair, each person will be required to complete the waiver. A parent or guardian must complete a waiver for any minor.

Please keep in mind that completion of this application is only an application to participate in the Solano’s Local Growers & Artist program. Submission of this application does not guarantee space at the Solano County Fair, nor does it constitute any agreement with the Fair to provide space, services or compensation.

IMPORTANT: Your application needs to include: a listing of products (with price point) to be sold, an outline of your 20 minute demonstration, the “title” of your presentation for the Solano County Fair daily schedule and your available times indicated on the schedule. After all participants have turned in their availability you will be emailed with your time slot.

Your proposed demonstration must be family-oriented and appropriate for all ages.

Solano County Fair Solano's Local Artists & Growers Waiver

In consideration for being permitted to participate in the Solano County Fair as a "Solano's Local Artists & Growers," I voluntarily release the Solano County Fair Association, the County of Solano, the State of California and each agency's officers, employees, agents and elective and appointed boards, from all claims, losses, damages, including property damages, personal injury, including death, costs and other liability of every kind, nature and description, directly or indirectly arising from my participation as a performer at the Solano County Fair. This Waiver has the effect of releasing, discharging, waiving and forever relinquishing any and all actions or causes or action that I may have or have had, whether past, present, future, whether known or unknown, and whether anticipated or unanticipated by me.

By signing the Waiver, I assume full responsibility for any and all property damage, personal injury or death suffered by me while participating as a performer in the Solano County Fair, even if such injuries or damages are caused by the acts or omissions of others.

This Waiver is binding upon me, my spouse, and any of my personal representatives, heirs, assigns, children and any guardian ad litem for said children.

I understand that if I were to file a lawsuit against any of the above-named entities, or any of their officers, agents, or employees as a result of any personal injury or property damage suffered by me while participating as a performer at the Solano County Fair, this Waiver would operate to bar the lawsuit and the lawsuit would be dismissed on the grounds that I have expressly assumed the risks of participation as a performer at the Solano County Fair.

I understand that if I am signing this Waiver on behalf of my minor child, that I will be giving up the same rights for said minor as I would be giving up if I signed this document on my own behalf.

I acknowledge that I have read this Waiver, that I understand the words and language in it, and that I enter into it voluntarily and agree to be bound by all its provisions.
