**Waiver:** If you or your group is selected to perform at the Solano County Fair, each performer will be required to execute a waiver. A parent or guardian must complete a waiver for any minor who will be performing.

Please keep in mind that completion and submission of this application is neither an offer nor a guarantee with the performer or their agent for a booking at the Solano County Fair, nor does it constitute any agreement with the Solano County Fair Association (SCFA) to provide space, services or compensation.

**IMPORTANT** – Your promotional packet needs to include one or more of the following: documentation citing past awards or recognition of the performer or group; letters of recommendation; a list of public appearances (including radio & TV); pictures; **AND** a video or audio sample of your performance. Performers may substitute a website address if the site contains all of the above elements or a combination of hard copy and website information. Acts that complement our Fair theme will get more consideration. EPK (electronic press kits) are encouraged. **Your proposed act must be family-oriented and appropriate for all ages.**

### 2018 Solano County Fair Cultural Pavilion Stage Entertainment Waiver

In consideration for being permitted to participate in the Solano County Fair as a Cultural Pavilion Stage Entertainer, I voluntarily release the Solano County Fair Association, the County of Solano, the State of California and each agency's officers, employees, agents and elective and appointed boards, from all claims, losses, damages, including property damages, personal injury, including death, costs and other liability of every kind, nature and description, directly or indirectly arising from my participation as a performer at the Solano County Fair.

This Waiver has the effect of releasing, discharging, waiving and forever relinquishing any and all actions or causes or action that I may have or have had, whether past, present, future, whether known or unknown, and whether anticipated or unanticipated by me.

By signing this Waiver, I assume full responsibility for any and all property damage, personal injury or death suffered by me while participating as a performer at the Solano County Fair, even if such injuries or damages are caused by the acts or omissions of others.

This Waiver is binding upon me, my spouse, and any of my personal representatives, heirs, assigns, children and any guardian ad litem for said children.

I understand that if I were to file a lawsuit against any of the above-named entities, or any of their officers, agents, or employees as a result of any personal injury or property damage suffered by me while participating as a perfomer at the Solano County Fair, this Waiver would operate to bar the lawsuit and the lawsuit would be dismissed on the grounds that I have expressly assumed the risks of participation as a performer at the Solano County Fair.

I understand that if I am signing this Waiver on behalf of my minor child, that I will be giving up the same rights for said minor as I would be giving up if I signed this document on my own behalf.

I acknowledge that I have read this Waiver, that I understand the words and language in it, and that I enter into it voluntarily and agree to be bound by all its provisions.
