- 1. Minutes of the monthly meeting of the Solano County Fair Association's Board of Directors held on July 19, 2017 at 6:00 pm in the Directors' Room with Vice-President Mike Coakley presiding.

- 3. PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Director Bell
- 4. <u>APPROVAL OF MINUTES OF THE BOARD MEETING OF June 21, 2017</u>: It was moved by Director Paterson and seconded by Director Marianno to approve the minutes of the June 21, 2017 Board meeting
  - **a.** The motion to approve the minutes was carried unanimously.
- 5. CHANGES OR DELETIONS FROM THE AGENDA: There were no changes to the agenda.

- 8. COMMITTEE REPORTS:
  - a. Ad Hoc Race Place
    - i. Director Yen reported that the committee met at Director Falati's office.
    - ii. There is an on-going discussion and evaluation concerning Farrington's Sports Bar proposal to add a mini-satellite wagering capacity to their operation.

The general feeling after reviewing the data is that Farrington would not negatively impact SCFA's wagering operation.

The committee will work towards bringing a detailed specific proposal back to the board at the September Fair Board meeting.

The next committee meeting is scheduled for August 15<sup>th</sup> with representatives of Farrington's present to enter into discussions.

## b. Hospitality Committee

i. Chair Placido reported that the committee had met earlier in the day. Directors Placido, Marianno, Coakley, Lisenko and Luiz in attendance.

Chair Placido circulated the pot luck sign-up sheet for the Director sponsored Opening Day BBQ.

Approximately 60 guests are to be invited. Directors are asked to arrive prior to the 3:00 pm fair opening. This will be a more low-key event comparative to Saturday's Celebrate Solano BBQ.

There was a discussion and update on the preparations for the Celebrate Solano BBQ.

## c. Silent Auction – Report on committee meeting of July 19, 2017

Chair Paterson reported that the committee had met earlier in the day. Chair Paterson
was very happy to report that there are 14 auction items with 9 being of a participatory
nature.

Chair Paterson asked the board to consider having another board member step forward and assume chairpersonship of this committee.

Chair Paterson would also like to acknowledge SCFA staff, specifically Marcia Coffman's efforts in support of the auction.

## d. Finance Committee – Report on Committee Meeting of July 19, 2017

- i. Vice-Chair Coakley reported that the Finance Committee met earlier in the day and recommended approval of the June 30, 2017 financial statements as presented.
- ii. **Action:** It was moved by Director Placido and seconded by Director Paterson to approve the June 30, 2017 financials as presented. The motion carried unanimously.

## 9. GENERAL MANAGER'S REPORT:

- **a. Update on Solano County Fair (August 2-6, 2017)** GM Hales reported that competitive entries are down slightly but with more entries still coming in the ending numbers should be close to last year's totals.
- **b. Update on Legislative Issues** loakimedes reported that both AB 1499 and SB 368 are moving forward.
  - i. **Solano Cities' Booth** loakimedes gave an update on the new format and the positive response from participating communities.
- **c. Horse Racing** GM Hales reported that the Race Place would be open on Wednesdays from now through Labor Day.
- **d.** Other Matters GM Hales reported on current on-going conversations between SCFA staff and the Solano County Sherriff's office. It was found that there was a formal M.O.U. between the Sherriff's office and SCFA that expired in 2004. Both parties are very interested in reviewing and updating the M.O.U. Discussions continue.

**Solano 360** – GM Hales reported that demolition planning is proceeding and the county is close to receiving the bid documents from the architectural firm hired to manage the demolition portion of the project. The haz-mat study has been received by Hales but not reviewed. The demo portion of the project is tentatively scheduled to begin in Spring 2018.

**Cell Phone Towers** currently located in the existing grand stand will need to be relocated. This is a top priority for SCFA staff as the cell phone towers (A.T. & T) generate revenue. Discussions are scheduled to begin after the completion of the 2017 Fair.

**Facility Improvements** – The \$1.7 million has been approved and budgeted into this fiscal year's county budget. The improvements are a secondary issue relative to the demo work, with more discussions anticipated for later this year.

**Solano Development Company** – While the exclusive negotiating rights option was not renewed there still might be interest on the part of the developer to explore possibilities. Updates to follow if more interest is shown.

- **a.** General discussion around not having a formal opening ceremony for this year's Fair. This issue will be re-visited prior to the 2018 Fair.

- **c.** The Board extended congratulations to Director Falati in recognition of his selection as Fairfield's 2017 Grand Marshall for their 4<sup>th</sup> of July festivities.
- **d.** Director Luiz announced that he is planning on retiring from the board after this year's Fair. The other directors expressed their appreciation for Director's Luiz long service to SCFA.
- **e.** There was a brief discussion as to future board appointments and future board composition.
