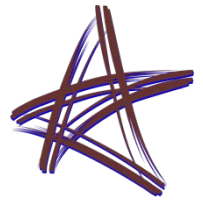

#### GENERAL RULES FOR ALL COMPETITIONS

- ★ Contestants must submit a video of their talent as part of the registration. Links to smartphone videos are okay.
- ★ Contestants may be of any age. Applicants under age 18 as of August 2, 2017 must have a legal guardian or conservator complete and sign the Registration & Authorizations Form.
- ★ All applicants must submit a completed Registration & Authorizations Form by the July 28 deadline.
- ★ These competitions are not affiliated with any other competitions. No further competition scheduled or implied.
- ★ Contestants will be judged on talent, stage presence and entertainment appeal.
- ★ If a duo, trio or group is competing, one cash prize will be awarded to the group. Cash prizes will not be awarded per contestant in the group.
- ★ Songs containing explicit language are not allowed.
- ★ Explicit dancing is not allowed.
- ★ Contestants may sing acapella or to professionally-recorded tracks, which the contestant must supply on a CD. Lead vocals on the track must have been removed.
- ★ Accompaniment to any form of live music is not allowed

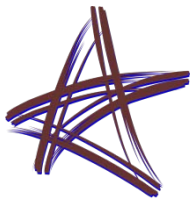

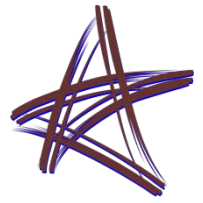
