By signing this Waiver, I assume full responsibility for any and all property damage, personal injury or death suffered by me while participating in the Solano County Fair, even if such injuries or damages are caused by the acts or omissions of others.

This Waiver is binding upon me, my spouse, and any of my personal representatives, heirs, assigns, children, and any guardian ad litem for said children.

I understand that if I were to file a lawsuit against any of the above-named entities, or any of their officers, agents, or employees as a result of any personal injury or property damage suffered by me while participating in the Solano County Fair, this Waiver would operate to bar the lawsuit and the lawsuit would be dismissed on the grounds that I have expressly assumed the risks of participation at the Solano County Fair.

I understand that I will be required to abide by all rules and regulations as outlined in the Exhibitor Handbook.

I acknowledge that I have read this Waiver, that I understand the words and language in it, and that I enter into it voluntarily and agree to be bound by all its provisions.
